Open Forum: 6:30pm to 7:02pm, Evan Haar had a discussion with the Council regarding the sewer line to the Youth Center.

Motion by Bobby, second by Barnhardt, to approve the agenda. All present voted yes. Motion carried.

Mayor Rick Boschee presented the 2024 Infection Prevention Plan approved by Dr. Kessler. Motion by Gunderson, Second by Barnhardt. All voted yes. Motion carried.

Mayor Rick Boschee presented the Surplus Item List. Motion by Maier, second by Shaykett. All voted yes. Motion carried.

Mayor Rick Boschee presented the Avel eCare Telemedicine Practitioners and the Avera Telemedicine Practitioner that Dr. Kessler approved. Motion by Barnhardt, second by Bobby. All voted yes. Motion carried.

Mayor Rick Boschee presented the Confidentiality/Privacy Statement form and the Conflict-of-Interest Disclosure Form for all council members to sign.

City Finance Officer, Carrie Poirier presented the November Financials and Statistics with breakdowns for each healthcare center department. Facility profits of 110,949.00 – YTD loss of 251,867, Hospital profit of 137,268 – YTD loss of 81,032, LTC loss of 2,531 – YTD loss of 96,073, Clinic loss of 23,788 – YTD loss of 74,762. Statistics detail: Acute hospital days down 46 YTD, Hospital Swing Bed days down 65 YTD, LTC days down 313 YTD, Outpatient visits up YTD, ER visits down YTD, Clinic visits up YTD, Lab tests down YTD, Radiology exams up YTD, Rehab visits like last year. They were reviewed by the council. Personnel change for December was two new hires, Libby Miner, LTC CNA FT, \$19.40/hour, Brookly Wenzel, Hospital LPN PT, \$23.40/hr. Separations: Ashley Washegesic – Radiology, Wage Increases: Lisa Geier, 25 yr. increase, 37.23, Hospital RN, and Kris Mitchell, 10 yr. increase, 37.71, MDS Coordinator. The motion to approve new hires was made by Gunderson, seconded by Barnhardt. All voted yes. Motion carried. Mayor Boschee extended a welcome to the facility to the new hire.

The Healthcare Center inquired about the City of Bowdle paying a Community Room monthly fee to cover utilities. The council approved 150.00/month. Motion to approve was made by Barnhardt, seconded by Shaykett. All voted yes. Motion carried.

F/O Poirier shared information concerning a municipal election. The notice of vacancies of positions on the council will be publicized during January. The following positions will be up for election during 2024: Mayor: one 2-year position, Ward One: one 1-year position, one 2-year position; Ward Two: one-2-year position; Ward Three: one 2-year position. The circulating of petitions can begin on Friday, January 26, 2024. All petitions must be turned in by 5:00 pm, Friday, February 23, 2024. If needed, the election will be held April 9, 2024.

In the last legislative session, a bill passed that would allow small communities to elect all council representatives at large, eliminating the need for wards, if the municipality elected to do so. To enact this, a city-wide election would need to have the question on the ballot and voted upon. This vote could take place at the same time as any election within the city. Maier made a motion to move forward with steps for placing the question on the ballot. Bobby seconded. All voted yes. Motion carried. Any individuals who would like to help get the matter on the ballot may circulate a petition to collect signatures to place on ballot.

Mayor Boschee gave a report on the progress of the street/sewer/water projects. The loan closing on the sewer project loan will close January 18, 2024.

F/O presented the council with November Monthly Receipts and Statement of Accounts.

City F/O requested that the Hospital F/O be on the hospital bank accounts and be responsible for signing the hospital accounts payable checks. City F/O would be removed from the hospital accounts. Motion to approve request was made by Bobby, second by Shaykett. All voted yes. Motion carried.

Fire Department requested that all utilities for the fire hall be paid for by the administrative portion of the city budget. Motion was made by Gab, second by Shaykett. All in favor. Motion carried.

The F/O shared that the SDML Government Day at the legislature is scheduled for Wednesday, February 7. Mayor Boschee, as district 6 chairperson, will be attending. Other council members were invited to join him in attending the SDML Government Day.

The next regular council meeting will be held Monday, February 5, 2024, at 6:30 pm in the Bowdle City Finance Office in the Fire Hall.

With no additional business, a motion was made by Bobby, seconded by Gunderson, to adjourn 9:32 pm. All present voted yes. Motion carried.
